# European and international business law (Lithuania-France-sheet 1)

### Double Master's degrees


- > one issued by MRU (Lithuania) or UNITO (Italy),
- > and the other by USMB (France).

These joint programmes are offered by Mykolas Romeris University - MRU (Vilnius Lithuania) - *sheet 1* or by the Università degli Studi di Torino - UNITO (Italy) - *sheet 2* and Université Savoie Mont Blanc - USMB (France). First year of studies is held at MRU or UNITO, second year at USMB. Graduates of these programmes will be awarded with two diplomas - one issued by MRU or UNITO, the other one by USMB. These programmes are fully taught in English - lectures face to face. Thus a perfect command of English is required. The nature of the trainings open up high-level international horizons.

## > Objectives

- Expression / Mobilisation at a high level of English proficiency
- Management of the various legal problems that companies may face
- Consideration of the financial and commercial constraints of companies
- Providing leading legal expertise on dispute resolution procedures
- Application of rules and principles relating to international contracts (European Union focus)
- Analysis and drafting of international contracts
- Handling of international litigation files

## > Peculiarities

**First year (M1) of studies is held at MRU (Lithuania) or UNITO (Torino), second year (M2) at Université Savoie Mont Blanc. Graduates of this programme will be awarded with two diplomas - one issued by MRU or UNITO, the other by USMB.**

- Study programme performed in English language
- The semester 4 of the second year is devoted to an internship in the field (in Europe in priority) and to the defence of a Master thesis both written in English

## > Prerequisites

A solid legal basis is recommended (university bachelor degree or its equivalent in law) to profitably follow these demanding Masters Courses aimed at training high-level European and international lawyers.

Applicants must have a sufficient knowledge in English, no less than the B2 level (according to the "Common European Framework of Reference for Languages", adopted by the European Council).

## > Courses

### First year (Mykolas Romeris University - Lithuania)

European and International Company Law, European and International Insolvency Law, International Banking Law, European and International Labour Law, International Tax Law, International Private Law, Foreign language (French or English), Industrial Property Law, European and International Competition Law, International Commercial Litigation, Master Thesis first steps (methodology).

### Second year (Université Savoie Mont Blanc - France)

Comparative contract Law and economic analysis, International transport Law, European and International Principles of Contract Law, Special contracts of international business, European Economic Integration, Contemporary issues of international business Law, Foreign language (English, French or Italian), Compulsory Conferences, Professional Internship (European Union preferably – worldwide or home Country) & Master Thesis and defence.

### Internship during second year

The main goals of the internship are: to deepen and consolidate knowledge in European and International business law acquired during the studies period; to improve skills both on theoretical and applied knowledge in the field; to get familiar with the features of professional work field.

- Mandatory
- Length: minimum 2 months
- Where: in France or abroad (preferably in Europe) in a public or private entity (law firms, legal expertise agencies, companies, International Organisations...)

## > What's next ?

- High-level legal expert in a public or private institution
- Or acquisition of a solid master degree in law entitles to continue studies in the legal area and other fields of research (social sciences) in order to possibly get a PhD in law or social sciences e.g.

## > Careers

Excellent opportunities of career and employment can be expected by the fact that the joint master programme will be carried out in universities of two different countries and thus this will give students opportunity to gain more diverse and multicultural experience, get more knowledge and skills, improve professional foreign languages skills, gain international work experience and develop the ability to work in an open world.
